General Liability Coverage and Defense

Liability defense of a French shipyard in the English High Court following a fire loss aboard a vessel while in dry dock (*Acergy Shipping Ltd v Societe Bretonne de Reparation Navale SAS* [2011] EWHC 2490 (Comm)).
